### 1) INTENT

The Board of Directors has adopted the following rules and regulations to ensure safety, to protect property and to ensure sanitary facilities. Affiliates are responsible for the conduct of their children and guests and are required to advise their children, guests and other Affiliates or members of infractions of these Rules or of our Bylaws. Violations of these Rules or Bylaws may subject offenders to disciplinary action by the Management and the Board of Directors.

### 2) AFFILIATE SPECIFIC RULES

a) Tennis Affiliates may renew annually for as long as the club continues to offer an Affiliate program. *The current program will terminate on 4/30/11 unless the Board of Directors and club membership approve this program as a permanent program.*

b) Tennis Affiliates have unlimited use of all tennis facilities and access to all tennis activities, programs and leagues.

c) Affiliates have access to any paid tennis activities at the GBSRC member rate.

d) Tennis affiliates may bring guests to play tennis. The guest must pay the regular guest fees. (See Guest regulations below).

e) Affiliates have no more rights of usage to the pool or clubhouse than any non-member who would visit the club as a guest of a member.

f) Affiliates agree to abide by the GBSRC Tennis Court Reservation policies and procedures. Said policies and procedures will be posted in the Tennis Pavilion and on the [www.gbsrc.org](http://www.gbsrc.org) website.

g) Tennis Affiliates may not hold GBSRC stock or have participation in the governance of the club. The Tennis Chair will represent their interests to the BOD.

h) Prior members who have left the club in good standing are eligible for the Tennis Affiliate Program. Current members in good standing are eligible to convert to the Tennis Affiliate Program, with full knowledge that the temporary program may not be renewed after 4/30/11. Also, even though they may still own club stock, these Affiliates will not participate in the governance of the club. If the Tennis Affiliate Program does not continue after 4/30/11, prior members may return to their previous membership status upon payment of appropriate yearly dues.

j) Tennis affiliates may upgrade their affiliate status to a full club membership at any time provided they pay prorated club dues, purchase the \$400 stock and pay the initiation fee that is in place at that time.

k) The cost is \$200 per individual or \$300 per family with no initiation fee. The dues will be based on a 5/1 start date and would be prorated according to the start date. Applications for this program will not be accepted after September, 30, 2010.
